## **Displays and Exhibits**

When space is available, the Brookfield Public Library welcomes temporary, noncommercial displays and exhibits of general interest to the community. The library will not advertise commercial endeavors unless for a charitable organization or specifically related to the goals of the library. The library will not accept any displays of a political or religious nature.

Temporary displays or exhibits may be used at the discretion of the Library Director or his/her designee. The library limits usage of space to one display area per yearly quarter by any group, organization or individual.

All materials in the library will be given reasonable care and protection within the limits of general operation of the library, but the Brookfield Public Library and the Library Board do not assume responsibility for damage or loss suffered on its premises, nor for the costs of insurance coverage. Such losses, damages, etc. are understood to be the responsibility of the organization or individual providing the display or exhibit. A signed statement of insurance coverage should be provided if the display/exhibit is insured. In all cases, a statement releasing the library from responsibility and indemnifying the library for any loss must be completed on the library's Display and Exhibit Form, attached.
